MINUTES ANNUAL GENERAL MEETING ON SATURDAY 19th OCTOBER 2024

On Saturday 19th October 2024 at 10:00am, the Ordinary General Assembly of the EuroMayenne Association, whose registered office is located at «*Maison des Associations*», 130 rue de la Visitation, Mayenne (53100), was held in the room of the old refectory at «*Maison des Associations*», 130 rue de la Visitation, in Mayenne (53100).

54 members were present or represented, the quorum being fixed at 30 members present or represented in the association's internal rules approved by the Executive Committee on 17th September 2022.

Nicole DEVEL-LAIGLE, President, opened the meeting and thanked the participants for their attendance. The President then informed the audience that the Executive Committee members would now like to share an important information with them.

This year, following a proposal from the President, they have reflected on a more collective governance of our association.

At their meeting on 8 June 2024, they decided that our association would from now on have 3 co-presidents in place of the President and 2 Vice-Presidents.

Then, at their meeting on 28 September 2024, they approved the division of responsibilities between the 3 co-Presidents as proposed by the Board members.

Following the election at the Executive Committee meeting this afternoon, EuroMayenne will have 3 copresidents and all our members will of course be informed of the result of this election.

4 - Financial Report 2023-2024

Roselyne SPEYER, treasurer of the association, presented the Financial Report and the Audit Report for 2023-2024.

The President thanked Roselyne SPEYER for her great efficiency in managing our accounts, as well as Anne DUGUERET, a EuroMayenne member, who has audited our accounts this year.

There were no questions in relation to these reports.

The Financial Report 2023-2024 and the Audit Report on the Accounts 2023-2024 were unanimously approved less one abstention.

5 - Election of Executive Committee Members

There was no AGM in 2020 because of the Covid pandemic and the confinements. There were therefore two AGMs in 2021, the one in 2020 postponed to March 2021 and the usual one in November 2021.

Consequently there were no Executive Committee member mandates coming to an end in 2023 and therefore no elections last year.

Today, the mandates of Nicole DEVEL-LAIGLE, Simon KING, Valérie MASSEROT, Georges PLESSIS, Paul PUNCHARD and Peter WOODS are coming to an end.

Ian WATSON and Lynn CHESTERS resigned from their positions as administrators in December 2023.

Valérie MASSEROT had decided not to stand for re-election and she was thanked warmly by the President for her commitment and participation on the Executive Committee.

This means that there are 8 vacancies.

On 8th June 2024, the Executive Committee decided to rebalance the mandates of the Executive Committee members, with 4 mandates until 2025, 4 mandates until 2026 and 4 mandates until 2027.

Nicole DEVEL-LAIGLE, Simon KING, Georges PLESSIS and Peter WOODS are standing for re-election and have agreed to serve a 2-year term until 2026, in order to rebalance the mandates on the Executive Committee.

Paul PUNCHARD is also standing for re-election for a further 3-year term until 2027.

Susan JAMESON was co-opted by the Executive Committee on 20th April 2024 and is standing for re-election for a 3-year term ending in 2027.

A call for applications had been emailed by the President to all members on 19th September 2024.

2 applications had been received: Patrice BOMPAIS and Sheelagh ABBOTS, for a 3-year mandate until 2027.

The 8 candidates presented their candidatures in alphabetical order:

Sheelagh ABBOTS (absent, candidature read by Nicole DEVEL-LAIGLE), Patrice BOMPAIS (absent, candidature read by Martine BOMPAIS), Nicole DEVEL-LAIGLE, Susan JAMESON, Simon KING, Georges PLESSIS, Paul PUNCHARD and Peter WOODS.

There were no questions in relation to this election.

As there were no more candidates than positions to be filled, the President asked if the participants agreed to vote with a show of hands. There were no objections.

Results of the vote

- Nicole DEVEL-LAIGLE, Simon KING, Georges PLESSIS and Peter WOODS were unanimously re-elected for two vears.
- Paul PUNCHARD was unanimously re-elected for three years.
- Sheelagh ABBOTS, Patrice BOMPAIS and Susan JAMESON were unanimously elected for three years.

Following this AGM, the Executive Committee will meet and elect the Officers (3 Co-Presidents, Treasurer, Deputy Treasurer, Secretary, Deputy Secretary).

5 - Any other Business

There were no questions or information for those attending this AGM.

As there was no other item on the agenda, the meeting was closed at 11:44am and the President invited those present to a convivial aperitif.
